Submission for approval of contracts and transactions with related parties

Bid package: Construction of test piles for the entire project and mass piling works for the CC06 apartment block; and Bid package: Consultancy services for supervision of test pile construction for the entire project, mass piling works for the CC06 apartment block, and test pile testing

In implementation of the resolution of the Board of Directors of the Corporation regarding the approval of the implementation plan and the selection of contractors for the following bid packages: construction of test piles for the entire project and mass piling works for the CC06 apartment block; and consultancy services for supervision of test pile construction for the entire project, mass piling works for the CC06 apartment block, and test pile testing, under the Social Housing Apartment Complex Project on the 3.71-hectare land plot in Phuoc An Commune, Dong Nai Province, the Board of Directors of the Corporation has approved the selection of Mechanical Construction and Installation Joint Stock Company as the contractor for the bid package on construction of test piles for the entire project and mass piling works for the CC06 apartment block, and Housing Consulting – Design – Construction – Business Joint Stock Company as the contractor for the bid package on consultancy services for supervision of test pile construction for the entire project, mass piling works for the CC06 apartment block, and test pile testing. Whereby, Mechanical Construction and Installation Joint Stock Company is an affiliated company of the Corporation (the Corporation's capital contribution ratio: **28.53%**), and Housing Consulting – Design – Construction – Business Joint Stock Company is an affiliated company of the Corporation (the Corporation's capital contribution ratio: **36%**).

Pursuant to Article 167 of the Law on Enterprises 2020 regarding the approval of contracts and transactions between a company and its related parties, in order to complete the procedures in accordance with regulations, the General Director respectfully submits to the Board of Directors of the Corporation for consideration and approval the above-mentioned contract with Housing Consulting – Design – Construction – Business Joint Stock Company, with the principal contents as follows:

I. Package: Construction of test piles for the entire project and mass piling works for the CC06 apartment block

1. Contract: Construction of test piles for the entire project and mass piling works for the CC06 apartment block – Social Housing Apartment Complex Project on the 3.71-hectare land plot in Phuoc An Commune, Dong Nai Province.
2. Contractor: Mechanical Construction and Installation Joint Stock Company.
3. Form of contract: Fixed unit price contract.
4. Contract value: VND 5,525,868,000 (inclusive of 8% VAT).

II. Package: Consultancy services for supervision of test piles and mass piling works for the CC06 apartment block, including test pile testing
